We also confirm that we don't use any Phthalates, Bisphenol A, PAH and Animal Derived Ingredients (ADI) for the production of our hoses and that they comply with the latest REACH regulation. Even if these components are excluded from our production process, we cannot exclude cross-contamination that is beyond our intent and control.

This declaration cannot be extended for further processing carried out on the Product or for its improper use. In particular, the need to maintain the traceability chain of the Product is underlined, being by its nature a component for assemblies and that its correct storage is an integral part of maintaining its suitability for food contact.

The user's assessment of the technological suitability for the purpose for which it is intended and its compliance with current regulations is not excluded from this document.
